**Programming public space: 135 days of programming in parks, plazas, and other public spaces of NYC, using pop-up, portable reading rooms and other environments that we created and operated. Serving approximately 8,100 people in 33 neighborhoods of the (85% of time spent in low/moderate-income areas). Many thousands more people observed others reading, drawing, or learning on the in passing. Surveys and other feedback and documentation suggested that our pop-up learning environments increased access to educational materials; led people to spend more time learning; made people feel safer and more connected to their neighbors; made people feel good about themselves, their community, and the city. All programming was in response to requests from community groups or city agencies. To achieve this level of service, we hired 6 seasonal staff members, contracted two students in a federal work-study program (through Massachusetts Institute of Technology Public Service Center), contracted two movers, and had help from 22 active volunteers. We maintained storage in Brooklyn, and all office work took place in donated space in Leslie and Sam Davol's home.**

**Programming public space through partnerships: Fifteen partnerships for programming public space using pop-up, portable learning environments that we made and provided to public libraries and other organizations in: New York City (NYPL, FDR Four Freedoms Park, and NYC DOT); Boston (Rose Kennedy Greenway Conservancy); Onondaga County, NY (library); Hennepin County, MN (library); Gwinnet County, GA (library); Montgomery County, PA (library); New Orleans, LA (Playbuild NOLA); Calgary, Canada (library); and Astana, Kazakhstan (US Embassy). All in response to demand. (Note that some expenses related to revenue generated were not incurred until 2017.)**
